Prior to drafting any contract of goods or services the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.

METHOD OF PAYMENT

Payment for goods and services is expected at the time of arrangement and required **prior** to casketing or cremation. For your convenience, we accept **cash**, in-state **check**, **credit card** (Visa, MasterCard, Discover, and American Express) or an approved **irrevocable trust or a funeral insurance policy**

This General Price List outlined the services and merchandise that we can provide to our customers along with our current prices. From it, you may select only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean, you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Basic Services of Funeral Director/Staff and Overhead\$1,995.00

This fee for our basic services and overhead will be added to the total cost of the funeral arrangement you select. **(This fee is already included in our charges for Direct cremation, immediate burial, and forwarding or receiving of remains)**

This fee includes the following: personnel available 24 hours a day, 365 days a year to respond to initial calls, arrangement of service, tribute, or memorial service, and clerical assistance in the completion of various forms and permits associated with a funeral and death certificate, preparation costs, government, compliance, insurance, and administrative expenses_

Preparation of the Body

Embalming.....\$795.00

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want involving, you usually have the right to choose an arrangement that does not require you to pay it, such as direct cremation or immediate burial.

Dressing, Casketing, Cosmetology & Basic Hairdressing.....\$595.00

Refrigeration.....\$595.00

Refrigeration is required by the State of California regulation. Our initial fee covers up to **7 days**. **Beginning on the 8th day the funeral home will charge \$195.00 for each additional day of refrigeration.**

Removal of Medical Devices/Pacemaker Prior to cremation.....\$295.00

Sanitary care of un-embalmed remains \$295.00

Transportation

Transfer of Remains to the Funeral Home..... \$495.00
Beyond 20-mile radius we charge an additional \$4.75 per mile.

Hearse (1-4 hrs.).....\$695.00

Direct Cremation.....\$1,545.00 to \$1,695.00

Infant under 2 yrs of age..... \$745.00 to \$895.00

Our charge for direct cremation (without ceremony) includes refrigeration, basic services of funeral director and staff, removal of remains, transportation to the crematory, necessary authorizations, and cremation processes. **Our charges apply to individuals weighing less than 301 LBS. An additional charge of \$795 for individuals weighing 301 to 350 LBS will be added.** If you want to arrange for a direct cremation, you can use an alternative container. An alternative container encases the body and can be made of material like fiberboard or composite materials with or covering. The containers we provide are a fiberboard container. The Crematory only allows fiberboard containers for cremation.

Forwarding of Remains to another Funeral Home..... \$2,695.00
 Our charge includes basic service of funeral director and staff, removal and transportation of remains to our facility, embalming and other preparations of the remains if relevant, necessary authorizations, and local transportation to the receiving funeral home or airport. **This charge does not include casket, air-tray/combo unit, or common carrier charges.**

Receiving of Remains from another Funeral Home..... \$2,195.00
 Our charge includes basic services of funeral director and staff, care of the remains, transportation to funeral home and cemetery or crematory.

Immediate Burial..... \$3,295.00
 Charges include basic services of funeral director and staff, removal of remains to the funeral home, refrigeration, dressing, casketing, transportation to local cemetery, preparation of necessary permits and authorizations. **This charge does NOT include casket, cemetery or government fees, rites or ceremonies at the funeral home, graveside or elsewhere, the use of staff nor any other service or merchandise not specifically listed. This charge is in addition to the cost of the casket. (See casket price list).**
